Resolution authorizing the San Francisco Port Commission to accept and expend a grant in the amount of \$450,000 from the Governor's Office of Homeland Security for purchase of security enhancements

WHEREAS, The 2005 Department of Homeland Security Appropriations Act provides funds for a competitive grant program to address physical security enhancements for critical national seaports; and

WHEREAS, Through this program, the Governor's Office of Homeland Security preliminarily awarded the Port of San Francisco \$450,000 to purchase security enhancements; and,

WHEREAS, On October 27, 2005, the Governor's Office of Homeland Security approved the Port's application for specific emergency communications equipment, emergency power circuitry upgrade equipment, security fencing, emergency lighting and signboards, as well as new security camera systems for the Ferry Building and Pier 50; and,

WHEREAS, The Port Commission by Resolution No. 05-67, dated November 10, 2005 authorized the Port's Executive Director to accept and expend the \$450,000 in Governor's Office of Homeland Security grant funds for these security enhancements; and,

WHEREAS, The Port Commission proposes to maximize use of available grant funds on program expenditures by not including indirect costs in the grant budget; now, therefore, be it

RESOLVED, That the Board of Supervisors authorizes the San Francisco Port Commission to accept and expend \$450,000 in grant funds from the Governor's Office of Homeland Security; and be it

FURTHER RESOLVED, That the Board of Supervisors hereby waives inclusion of indirect costs in the grant budget; and be it

FURTHER RESOLVED, That the Board of Supervisors hereby authorizes the San Francisco Port Commission to execute any documents required for the implementation of this grant, including any amendments, augmentations or extensions thereof; and be it

FURTHER RESOLVED, That the Executive Director of the Port, or her designee, is authorized to approve, sign and execute an agreement to hold the granting agency harmless from liability arising out of this Project.
