10 WHEREAS, In 1979 he was appointed to by Governor Edmund G. Brown Jr., to the  
11 San Francisco Municipal Court and was re-elected twice, and was Presiding Judge in 1983-  
12 84; and,

13 WHEREAS, He served as Assistant District Attorney from 1977-79 and from 1970-77  
14 he honed his advocacy skills working as an attorney for the San Francisco Legal Assistance  
15 Foundation and California Rural Legal Assistance; and,

16 WHEREAS, He has taught at Lincoln University School of Law, the California Center  
17 for Judicial Education and Research, Continuing Education of the Bar Programs, and The  
18 Rutter Group Programs; and,

19 WHEREAS, He received his B.A. from UC Berkeley and his J.D. from Hastings  
20 College of the Law; and,

21 WHEREAS, He is a member of numerous professional organizations including the La  
22 Raza Bar Association and the Hispanic National Bar Association; and,

23 WHEREAS, In 1998 he was named Superior Court Judge of the Year by the San  
24 Francisco Trial Lawyers Association; now, therefor, be it


