3 **Resolution enacting and rescinding parking regulations at various locations.**

5 RESOLVED, That, in accordance with the provisions of the California Vehicle Code
6 and the San Francisco Traffic Code, the following regulations governing the parking of
7 vehicles are hereby enacted or rescinded as designated below:

8 **UNMETERED MOTORCYCLE PARKING - ESTABLISH**

9 285 Dorland Street, south side, between the driveways of #285 and #295 Dorland
10 Street (establishes three motorcycle parking spaces in this 14.5 foot space).

11 **TOW-AWAY, NO STOPPING, 4 PM TO 6 PM, MONDAY THROUGH FRIDAY - RESCIND**

12 Folsom Street, west side, between Cesar Chavez Street and 26th Street.

13 **PERPENDICULAR (90-DEGREE ANGLE) PARKING - ESTABLISH**

14 Mississippi Street, west side, north of 25th Street to the terminus

15
16 **PARKING METER AREA NO. 3 (2-HOUR PARKING TIME LIMIT, 9 AM TO 6 PM, MONDAY THROUGH SATURDAY) - ESTABLISH**

17 Green Street, south side, from Battery Street to 140 feet westerly; and,


