9 WHEREAS, SFDPH has applied for and been awarded a grant in the amount of  
10 \$271,665 from OMH to enhance the capacity of local minority-based HIV/AIDS organizations  
11 in San Francisco; and,

12 WHEREAS, As a condition of receiving the grant funds, OMH requires the City to enter  
13 into an agreement (the "Agreement"), a copy of which is on file with the Clerk of the Board of  
14 Supervisors in File No. 060024; which is hereby declared to be a part of this  
15 resolution as if set forth fully herein; and,

16 WHEREAS, Resolutions authorizing the acceptance and expenditure of grant funds  
17 may be placed automatically on consent agendas in committee, as they are usually  
18 considered to be routine items, and this resolution authorizes the acceptance and expenditure  
19 of grant funding; and,

20 WHEREAS, The grant budget includes a provision for indirect costs of \$21,841; now,  
21 therefore, be it


22 RESOLVED, That SFDPH is hereby authorized to accept retroactively and expend a


