Resolution authorizing the San Francisco Department of Public Health (SFDPH) to accept and expend retroactively a grant in the amount of \$739,982 from the Department of Justice (DOJ) for supportive housing for chronically homeless offenders, to enter into an agreement for the use of these funds, and to add 1.5 new positions funded under this agreement; for the period of July 1, 2005 to June 30, 2006.

WHEREAS, SFDPH has been awarded a grant from DOJ in the amount of \$739,982 for supportive housing for chronically homeless offenders; and,

WHEREAS, As a condition of receiving the grant funds, DOJ requires the City to enter into an agreement (the "Agreement"), which is on file with the Clerk of the Board of Supervisors in File No. <u>060023</u>, which is hereby declared to be a part of this resolution as if set forth fully herein; and,

WHEREAS, 1.5 positions will be added through this agreement; and,

WHEREAS, This Resolution requires expedited review by the Board of Supervisors because notification of the award was not received by the SFDPH until September 7, 2005, and the start date for the grant is July 1, 2005; and,

WHEREAS, Resolutions authorizing the acceptance and expenditure of grant funds may be placed automatically on consent agendas in committee, as they are usually considered to be routine items, and this resolution authorizes the acceptance and expenditure of grant funding; and,

WHEREAS, The grant budget includes a provision for indirect costs totaling \$38,828; now, therefore, be it
