Resolution authorizing the Mayor's Office of Criminal Justice (MOCJ) to retroactively accept and expend a grant in the amount of \$248,170 from the Office of Juvenile Justice and Delinquency Prevention (OJJDP) through a subcontract with the University of California-San Francisco (UCSF) for the purpose of developing a city-wide Violence Prevention Plan.

WHEREAS, MOCJ is the lead programmatic and fiscal agency in administering the OJJDP/UCSF grant; and

WHEREAS, San Francisco was awarded two hundred forty-eight thousand, one hundred seventy dollars (\$248,170) from the Office of Juvenile Justice and Delinquency Prevention through a subcontract with UCSF; and

WHEREAS, MOCJ's subcontract budget includes a provision for indirect costs of \$24,817 (10% of the subcontract amount); now, therefore, be it

RESOLVED, That the City and County of San Francisco hereby authorizes MOCJ to retroactively accept and expend \$248,170 from the Office of Juvenile Justice and Delinquency Prevention through a subcontract with UCSF to develop a city-wide Violence Prevention Plan.
