3 **Resolution authorizing the San Francisco Public Library to accept and expend a**  
4 **bequest in the amount of \$12,403.52 from the EDGAR BOWERS estate for**

7 WHEREAS, EDGAR BOWERS was a distinguished American poet who earned his  
8 doctorate in English at Stanford University, taught at Duke University, Harpur College and the  
9 University of California at Santa Barbara, who was awarded the Bollingen Prize in poetry, and  
10 who was a San Francisco resident upon his death in February of 2000; and,

11 WHEREAS, EDGAR BOWERS generously included the San Francisco Public Library  
12 among the beneficiaries of the EDGAR BOWERS' estate; and,

13 WHEREAS, the San Francisco Public Library has already received a distribution of  
14 \$12,403.52 from the EDGAR BOWERS estate; and,

15 WHEREAS, the EDGAR BOWERS bequest would provide funding for needed  
16 improvements to the Main Library; and,

17 WHEREAS, the City recognizes the generosity of EDGAR BOWERS with sincere  
18 appreciation; now, therefore, be it


19 RESOLVED, That the Board of Supervisors hereby authorizes the City Librarian of the
