4 **Resolution approving the San Francisco Child Care Planning and Advisory Council**  
5 **Priorities for General Child Care and Development Expansion.**

7 WHEREAS, Pursuant to the California Department of Education, Child Development  
8 Division Management Bulletin 99-21, any new funds for child care must be allocated  
9 proportionally to the most underserved areas of California; and

10 WHEREAS, CDD Management Bulletin 99-21 also requires county/local child care  
11 planning councils (LPCs) to identify underserved areas within the County by zip code prior to  
12 the release of state funds for child care services; and,

13 WHEREAS, A subsequent Child Development Division Management Bulletin 03-05  
14 further clarifies the process to establishing child care priorities as follows: "by May 30 of each  
15 year, upon approval by the County Board of Supervisors and the County Superintendent of  
16 Schools each LPC shall submit to the Child Development Division the local priorities it has  
17 identified that reflect all child care needs in the county"; and,

18 WHEREAS, The San Francisco Child Care Planning and Advisory Council has  
19 prepared the its County Priorities Report Form for General Child Care and Development  
20 Expansion for submission for May 30, 2006 (attached), identifying San Francisco City and  
21 County child care priorities in public housing and in underserved areas by zip code; now,  
22 therefore, be it

23 RESOLVED, That San Francisco County Board of Supervisors approves the San  
24 Francisco Child Care Planning and Advisory Council Priorities for General Child Care  
25 Development and Expansion to the Child Development Division of State of California.


