[Need for Statewide Chemicals Policy]

Resolution urging San Francisco's State delegation to support statewide efforts to act on the recommendations of the report from the University of California: "Green Chemistry in California: A Framework for Leadership in Chemicals Policy and Innovation" and to develop regulations and policies that promote the production and use of less toxic chemicals.

WHEREAS, San Francisco's Precautionary Principle Ordinance (2003) states that every San Franciscan has an equal right to a healthy and safe environment, and that the duty to enhance, protect, and preserve San Francisco's environment rests on the shoulders of government, residents, citizen groups, and businesses alike; and

WHEREAS, The U.S. EPA, in a 1987 nationwide study, identified nearly 700 chemicals that have been released into the environment that are accumulating in human tissues; and

WHEREAS, Many of these chemicals enter the developing organ systems of fetuses and infants through the maternal bloodstream and through breast milk; and each month, an estimated 1,900 Californians are diagnosed with a preventable, deadly chronic disease that is attributable to chemical exposures in the workplace; and

WHEREAS, Current regulatory systems have proven ineffective in addressing these situations; and

WHEREAS, Local governments are responsible for protecting and preserving the environment by keeping hazardous materials and products out of landfills, waterways, and air; and

SUPERVISOR MIRKARIMI BOARD OF SUPERVISORS WHEREAS, San Francisco spends millions of dollars on programs and equipment aimed at managing wastes and preventing the release of toxins into the environment, and needs to support a comprehensive chemicals policy that prevents the toxins from entering the products and food supply in the first place; and

WHEREAS, The most effective way to prevent toxins from entering the environment is to replace toxic chemicals in products and foods with safer alternative chemicals; and

WHEREAS, The use of chemicals that are safer for biological and ecological systems will link economic development in California with improved health and environmental quality; and

WHEREAS, Countries around the world have recognized the need for a comprehensive chemicals policy approach in order to protect human health and the environment; and

WHEREAS, The University of California has released a detailed report on the regulation of chemicals and guidelines on the provision of new restrictions on toxic chemicals and incentives for less toxic alternatives; now, therefore be it

RESOLVED, That the Board of Supervisors urges our representatives in Sacramento to support statewide efforts to act on the recommendations of the University of California report, including the development of regulations and policies that promote the production and use of less toxic chemicals.
