4 **Resolution approving the Memorandum of Understanding between the San Francisco**  
5 **Police Department and the San Francisco Housing Authority for additional police**  
6 **services in designated Housing Authority Developments.**

8 WHEREAS, Various Housing Authority Developments are entirely within the  
9 boundaries of the City and County of San Francisco and are located on streets owned by the  
10 City and County of San Francisco; and

11 WHEREAS, The San Francisco Police Department is required to furnish or cause to be  
12 furnished to the tenants of such public housing developments police services of the same  
13 character and extent as are furnished, without a service fee, to other dwellings and inhabitants  
14 in the City and County of San Francisco; and,

15 WHEREAS, The San Francisco Police Department provides public law enforcement  
16 services in the City and County of San Francisco, which includes Housing Authority  
17 Developments; and,

18 WHEREAS, The Housing Authority has experienced various levels of crime, including  
19 drug and gang problems, at its Authority Housing Developments; and

20 WHEREAS, It is the common goal of the San Francisco Police Department and the  
21 Housing Authority to provide a supplemental law enforcement program to reduce crime and  
22 fear of crime in the Housing Authority Developments; and

23 WHEREAS, For the purpose of achieving such common goal, the Housing Authority  
24 has requested the San Francisco Police Department to provide supplemental law  
25 enforcement community policing services to certain of its Authority-owned, and annually

1 identified Housing Developments, over and above the law enforcement services provided to  
2 the public generally, for the period of two years starting July 1, 2006 and ending on June 30,  
3 2008; and

4 WHEREAS, The San Francisco Police Department is willing to make available, for a  
5 fee of one million dollars (\$1,000,000) a year, trained San Francisco Police Department  
6 personnel to provide supplemental law enforcement community policing services dedicated to  
7 designated Housing Authority Developments; now, therefore, be it

8 RESOLVED, That Board hereby approves the Memorandum of Understanding  
9 between the San Francisco Police Department and the San Francisco Housing Authority for  
10 supplemental law enforcement for the period of two years, starting July 1, 2006 and ending  
11 June 30, 2008, for the fee of one million dollars (\$1,000,000) a year.




