4 **for the Touro University Gay-Straight Alliance and commending the Touro University's**
5 **College of Osteopathic Medicine, the Gay and Lesbian Medical Association and the**
6 **American Medical Student Association for standing together with the Touro University**
7 **Gay-Straight Alliance to protest Touro University's abolition of the school's several**
8 **year old Gay-Straight Alliance.**

10 WHEREAS, Touro University – California, prides itself on its "...values that involve a
11 commitment to social justice, intellectual pursuit, and service to humanity;" and

13 WHEREAS, for the last four years, the Touro University Gay-Straight Alliance has been
14 on campus, and approved by both the Dean of Students and the Student Government; and

15 WHEREAS, the Touro University Gay-Straight Alliance promotes equitable health care
16 delivery through awareness and education, and represents and teaches diversity both on
17 campus and in medicine to students, teachers, and alumni; and

18 WHEREAS, Touro University has recently revoked the charter of the Gay-Straight
19 Alliance and suspended the College's financial support of the group; and be it

20 RESOLVED, that the Board of Supervisors urges Touro University to be true to their
21 "...values of social justice" and reconsider their directive to revoke the charter for the Touro
22 University Gay-Straight Alliance and continue to fund the Touro University Gay-Straight
23 Alliance; and be it

24 FURTHER RESOLVED, That the Board of Supervisors Commends the Touro
25 University's College of Osteopathic Medicine, the Gay and Lesbian Medical Association and

1 the American Medical Student Association for standing together with the Touro University
2 Gay-Straight Alliance to protest Touro University's abolition of the school's several year old
3 Gay-Straight Alliance.




