3 **Resolution enacting and rescinding traffic regulations on various streets.**

5 RESOLVED, That, in accordance with the provisions of the California Vehicle Code  
6 and the San Francisco Traffic Code, the following regulations governing the movement of  
7 vehicles are hereby enacted or rescinded as designated below:

8  
9 **BICYCLE LANES - ESTABLISH**

10 Sloat Boulevard, both directions, from Skyline Boulevard to The Great Highway.

11 **RIGHT LANE MUST TURN RIGHT - RESCIND**

12 Sloat Boulevard, eastbound, from Skyline Boulevard to 300 feet westerly.

13 **RIGHT LANE MUST TURN RIGHT EXCEPT MUNI - ESTABLISH**

14 Sloat Boulevard, westbound, from 37th Avenue to 39th Avenue; and,

15 Sloat Boulevard, eastbound, from Skyline Boulevard to 350 feet westerly.

18 Categorically exempt from Environmental  
19 Review Class 1(c)(9) changes in the traffic and  
20 parking regulations where such changes do not  
21 establish a higher speed limit or result in more  
22 than a negligible increase in the use of the  
23 street.


