3 **Resolution determining that the transfer of a Type 20 off-sale beer and wine**
4 **license from 1701 Greenwich Street to 1415 Green Street and the issuance of a**
5 **Type 42 on-sale beer and wine public premises license at the same location to**
6 **Ceri Lyn Smith for Biondivino will serve the public convenience and necessity of**
7 **the people of the City and County of San Francisco, in accordance with Section**
8 **23958.4 of the California Business and Professions Code, with conditions.**

10 WHEREAS, Ceri Lyn Smith is seeking transfer of a Type 20 off-sale beer and
11 wine license and the issuance of a Type 42 on-sale beer and wine public premises
12 license for Biondivino located at 1415 Green Street; and,

13 WHEREAS, The Planning Department has verified that the area is properly
14 zoned and recommends approval with conditions; and,

15 WHEREAS, The Police Department recommends that the liquor license
16 application be approved with conditions; now, therefore, be it

17 RESOLVED, That in accordance with Section 23958.4 of the California Business
18 and Professions Code, the Board of Supervisors of the City and County of San
19 Francisco hereby determines for the foregoing reasons that the transfer of a Type 20
20 off-sale beer and wine license from 1701 Greenwich Street to 1415 Green Street and
21 the issuance of a Type 42 on-sale beer and wine public premises license to Ceri Lyn
22 Smith for Biondivino, will serve the public convenience and necessity of the people of
23 the City and County of San Francisco.

24 Conditions: 1) Sales and service of alcoholic beverages shall be permitted only
25 between the hours of 9:00 a.m. to 11:00 p.m. each day of the week. 2) Petitioner(s)

1 shall not permit their patrons or the general public to loiter or congregate on the
2 sidewalks adjacent to the licensed premises. 3) The petitioner(s) shall be responsible
3 for maintaining free of litter the area adjacent to the premises over which they have
4 control. 4) There shall be no coin operated games or video machines maintained upon
5 the premises at any time. 5) No noise shall be audible beyond the area under control of
6 the licensee. 6) The sale of beer and malt products shall be limited to those imported
7 from Italy. No other beer or malt products shall be offered for on or off-sale
8 consumption or purchase.


