5 **to support the Department's efforts to address Disproportionate Minority Contact**
6 **(DMC).**

8 WHEREAS, The Corrections Standards Authority (CSA) administers grant funds to
9 assist probation departments in understanding and identifying Disproportionate Minority
10 Contact (DMC), which refers to the overrepresentation of minority youth who come into
11 contact with the juvenile justice system relative to their numbers in the general population, and
12 to equip these agencies with the tools and resources needed to provide leadership in
13 developing and/or strengthening community-based DMC reduction activities; and

14 WHEREAS, The City and County of San Francisco desires to participate in the
15 Enhanced DMC Technical Assistance Project supported by federal Formula Grant funds and
16 administered by the CSA to address DMC issues in the San Francisco juvenile justice system;
17 and

18 WHEREAS, The San Francisco Juvenile Probation Department has established a
19 standing working committee, comprised of system and community stakeholders, that has
20 developed a strategy and scope of work to address and abate DMC; now, therefore, be it

21 RESOLVED, That the Board of Supervisors intends to further support efforts to reduce
22 DMC by providing future funding related to implementing these strategies, and, be it;



23 FURTHER RESOLVED, That the Chief Probation Officer of the San Francisco Juvenile
