4 **Resolution approving the reprogramming and expenditure of One Hundred Twenty-One**
5 **Thousand Two Hundred and Fifty Dollars (\$121,250.00) of Community Development**
6 **Block Grant funds and Fifty Thousand Dollars (\$50,000.00) of Emergency Shelter Grant**
7 **funds.**

9 WHEREAS, Each year the City and County of San Francisco receives Community
10 Development Block Grant ("CDBG") and Emergency Shelter Grant ("ESG") funding under
11 Title I of the Housing and Community Development Act of 1974, as amended; and,

12 WHEREAS, The Mayor's Office of Community Development ("MOCD") prepared
13 proposals for the acceptance and expenditure of CDBG funds for fiscal years 2005-2007, and
14 ESG funds for fiscal year 2005-2007, and the Board of Supervisors approved the acceptance
15 and expenditure of such funds in accordance with MOCD proposals by Resolution Nos. 295-
16 05 and 277-06 for CDBG and 294-05 and 276-06 for ESG respectively (the "Authorizing
17 Resolutions"); and,

18 WHEREAS, MOCD has closed out grants made pursuant to the Authorizing
19 Resolutions, and as a result MOCD has recaptured unexpended CDBG funds in an amount
20 equal to One Hundred Twenty-One Thousand Two Hundred and Fifty Dollars (\$121,250.00)
21 and has recaptured unexpended ESG funds in an amount equal to Fifty Thousand Dollars
22 (\$50,000.00) (collectively, the "Recaptured Funds"); and,

23 WHEREAS, MOCD has reprogrammed the Recaptured Funds as set forth in the
24 CDBG/ESG November 2006 Reprogramming Summary, a copy of which is located in Board
25 File No. 061604; and,


1 WHEREAS, MOCD's Certifying Officer shall follow the procedural provisions of NEPA
2 to make certain that all projects using Recaptured Funds are performed and spent in
3 compliance with the applicable NEPA provisions and requirements; now, therefore, be it

4 RESOLVED, That the Board of Supervisors hereby approves the reprogramming and
5 use of the Recaptured Funds in accordance with the Summary attachment; and, be it

6 FURTHER RESOLVED, That MOCD is hereby authorized to enter into such
7 agreements and take such actions as are consistent with CDBG/ESG November 2006
8 Reprogramming Summary; and, be it


9 FURTHER RESOLVED, That MOCD is hereby authorized to submit such


