3 **Resolution designating certain intersections as "STOP" intersections.**

5 RESOLVED, That, pursuant to the provisions of the California Vehicle Code, the
6 following intersections are hereby designated as "STOP" intersections, and the
7 Department of Parking and Traffic is hereby authorized and directed to cause "STOP"
8 signs to be installed thereat as designated below:

9 **STOP SIGNS - ESTABLISH**

10 Castenada and Magellan Avenues, stopping Magellan Avenue;

11 Stillings, Detroit and Vista Verde, stopping Detroit Street and Vista Verde Court,
12 making this uncontrolled intersection a two-way STOP;

13 19th Street and Caselli Avenue, stopping 19th Street, making this uncontrolled
14 intersection a two-way STOP;

15 Hermann and Webster Streets, stopping Hermann Street, making this
16 intersection an All-Way STOP;

17 21st and Florida Streets, stopping 21st Street, making this intersection an All-
18 Way STOP.;

19 Chestnut and Avila Street, stopping Avila Street; and,

20 Mallorca and Chestnut Street, stopping Mallorca Street.

21 Categorically exempt from Environmental
22 Review Class 1(c)(9) changes in the traffic and
23 parking regulations where such changes do not
24 establish a higher speed limit or result in more
25 than a negligible increase in the use of the
street.


