

1 [Grant to improve care for patients in San Francisco with anxiety disorders.]

3 **Resolution authorizing the San Francisco Department of Public Health, Community**
4 **Behavioral Health Services (DPH – CBHS) to accept and expend a new 24-month grant**
5 **in the amount of \$377,345, from the Mylan Settlement Fund (State of Connecticut, et al.**
6 **v. Mylan Laboratories), to provide services for patients with anxiety disorders; for the**
7 **period of June 1, 2007 through May 31, 2009.**

9 WHEREAS, DPH - CBHS was awarded a new grant from the Mylan Settlement Fund in
10 the amount of \$377,345 to improve services for patients with anxiety disorders; and,

11 WHEREAS, The goals of this project are to a) improve the ability of primary care
12 physicians to identify patients suffering from anxiety disorders, b) increase access of these
13 patients to psychiatric evaluations, and c) enable patients with anxiety disorders to receive
14 appropriate medication and treatment; and,

15 WHEREAS, As a condition of receiving the grant funds, CDHS requires the City to
16 enter into an agreement (the "Agreement"), a copy of which is on file with the Clerk of the
17 Board of Supervisors in File No. 070454; which is hereby declared to be a part of
18 this resolution as if set forth fully herein; and,

19 WHEREAS, The grant includes funds for part-time personnel, including reimbursement
20 for an existing position (Assistant Health Educator, Job Class 2819 at .15 FTE) and the hiring
21 of a new position (Senior Physician Specialist, Job Class 2232 at .30 FTE), for the period of
22 July 1, 2007 to May 31, 2009; an ASO amendment is not required because the new position
23 will be approved through the DPH budget process, with a start date in FY 2007-08; and,

24 WHEREAS, Resolutions authorizing the acceptance and expenditure of grant funds
25 may be placed automatically on the consent agendas in committee, as they are usually

1 considered to be routine items, and this resolution authorizes the acceptance and expenditure
2 of grant funding; and,

3 WHEREAS, The grant budget includes a provision for indirect costs of \$14,090; now,
4 therefore, be it

5 RESOLVED, That DPH - CBHS, is hereby authorized to accept and expend a grant in
6 the amount of \$377,345 from the Mylan Settlement Fund; and, be it


7 FURTHER RESOLVED, That SFDPH is hereby authorized to accept and expend the
8 grant funds in accordance with the requirements set forth in the Agreement, pursuant to San
9 Francisco Administrative Code section 10.170-1; and, be it

10 FURTHER RESOLVED, That the Director of Health is authorized to enter into the
11 agreement on behalf of the City; and, be it

12 FURTHER RESOLVED, That the Controller is directed to designate all positions
13 funded under this agreement as "G" or grant-funded positions which would terminate when
14 the agreement expires.


