3 **Resolution authorizing the San Francisco Department of Public Health (DPH) to accept**  
4 **and expend a grant for \$387,557 from the California Office of Traffic Safety (OTS),**  
5 **which includes contracts with the San Francisco Study Center for \$78,750 and O'Rorke,**  
6 **Inc. for \$80,000; for the period of January 1, 2008 through September 30, 2009.**

8 WHEREAS, DPH's Community Health Education Section was awarded a grant from  
9 OTS for \$387,557 for the period of January 1, 2008 through September 30, 2009 for a project  
10 designed to improve child safety and occupant protection in San Francisco; and,

11 WHEREAS, DPH selected two contractors through RFQ #1-2007 to assist with this  
12 project, including San Francisco Study Center for fiscal intermediary services for \$78,750 and  
13 O'Rorke, Inc. for media services for \$80,000, both for the period of January 1, 2008 through  
14 September 30, 2009; and,

15 WHEREAS, As a condition of receiving the grant funds, OTS requires the City to  
16 comply with the term of the agreement (the "Agreement"), a copy of which is on file with the  
17 Clerk of the Board of Supervisors in File No. 071391, which is hereby declared to  
18 be a part of this resolution as if set forth fully herein; and,

19 WHEREAS, An ASO amendment is not required because funding will be used to  
20 support two positions that already exist within DPH, including Health Educator, .50 FTE (Job  
21 Class #2822) and Health Worker II, .70 FTE (Job Class #2586); and,


22 WHEREAS, The budget includes a provision for indirect costs of \$27,810; now,  
23 therefore, be it

24 **RESOLVED, That DPH is hereby authorized to accept and expend this grant in the**  
25 **amount of \$387,557 from OTS; and, be it**

1 FURTHER RESOLVED, That the Director of Health is authorized to enter into the  
2 agreement for the period of January 1, 2007 through September 30, 2008; and, be it


3 FURTHER RESOLVED, That the Controller is directed to designate the position funded


