3 **Resolution authorizing the San Francisco Department of Public Health (DPH) to accept**  
4 **and expend retroactively a grant from the Substance Abuse and Mental Health Services**  
5 **Administration and the Center for Substance Abuse Treatment (SAMHSA/CSAT) in the**  
6 **amount of \$397,919 for the period of September 30, 2007 through September 29, 2008,**  
7 **and a subcontract with Asian and Pacific Islander Wellness Center for \$318,619 for the**  
8 **same time period.**

10 WHEREAS, DPH was awarded a grant from SAMHSA/CSAT in the amount of  
11 \$397,919 for a project entitled Transgender Health and Resources Initiative for Vital  
12 Empowerment (THRIVE) to expand the treatment capacity for the Transgender population in  
13 San Francisco; and,

14 WHEREAS, DPH will collaborate with the Asian and Pacific Islander Wellness Center,  
15 a community-based organization with a proven history of providing comprehensive services  
16 for Gender Variant Individuals, through a subcontract in the amount of \$318,619; and,

17 WHEREAS, As a condition of receiving the grant funds, SAMHSA/CSAT requires the  
18 City to enter into an agreement (the "Agreement"), a copy of which is on file with the Clerk of  
19 the Board of Supervisors in File No. 071594; which is hereby declared to be a part  
20 of this resolution as if set forth fully herein; and,

21 WHEREAS, The grant does not require an ASO amendment and reimburses the  
22 department for existing positions, including Epidemiologist I (Job Class #2802) at .15 FTE,  
23 and two Health Worker II (Job Class #2586) at .50 FTE each, and the Project Investigator's  
24 time (Job Class #0922) will be in-kind; and,

1 WHEREAS, The grant budget includes a provision for indirect costs in the amount of  
2 \$7,476; now, therefore, be it


3 RESOLVED, That DPH is hereby authorized to accept and expend retroactively a grant  
4 in the amount of \$397,919 from SAMHSA/CSAT; and, be it

5 FURTHER RESOLVED, That DPH is hereby authorized to retroactively accept and  
6 expend the grant funds pursuant to San Francisco Administrative Code section 10.170-1; and,  
7 be it

8 FURTHER RESOLVED, That the Controller is directed to designate the positions  
9 funded under this agreement as a "G" or grant-funded position which would terminate when  
10 the agreement expires.


11 FURTHER RESOLVED, That the Director of Health is authorized to enter into the


