3 **Resolution urging the Mayor to reinstate hiring of all vacant recreation director**

7 WHEREAS, Due to a projected budget shortfall, Mayor Gavin Newsom has declared a  
8 hiring freeze for all non-essential positions; and,

10 WHEREAS, Recreation directors, who are charged with managing and staffing our  
11 city's recreation centers, have been designated non-essential employees and, thus, vacant  
12 Recreation Director positions are subject to the hiring freeze; and,

13 WHEREAS, Recreation facilities are critical for keeping families in San Francisco, for  
14 whom City recreation facilities function as a living room and backyard; and,

15 WHEREAS, Recreation facilities provide critical support to the City's violence  
16 prevention efforts by offering after school programming and activities; and

16

17 WHEREAS, Recreation Directors recognize the needs of their neighborhood and can  
18 design and implement programs which fulfill the needs of those communities who use their  
19 facilities; and,

19

20 WHEREAS, Staff shortages and reduced hours in recreation centers and clubhouses  
21 result in under use of these valuable resources; now, therefore, be it

22 RESOLVED, That the San Francisco Board of Supervisors urges the Mayor to declare  
23 Recreation Directors as essential employees and to unfreeze hiring efforts for all recreation  
24 director positions; and, be it




