WHEREAS, Staff shortages and reduced hours in recreation centers and clubhouses result in under use of these valuable resources; now, therefore, be it

RESOLVED, That the San Francisco Board of Supervisors urges the Mayor to declare Recreation Directors as essential employees and to unfreeze hiring efforts for all recreation director positions; and, be it
