3 **Resolution authorizing the Airport Commission to accept and expend funding in a total**
4 **amount of \$849,126 from the Transportation Security Administration ("TSA") for the**
5 **Airport K-9 Explosives Detection Team Program.**

7 WHEREAS, The Airport utilizes canine (K-9) teams to detect explosives at the Airport;
8 and,

9 WHEREAS, The Airport K-9 Explosives Detection Team Program incurs expenses for
10 handler salaries, handler overtime, handler uniforms (laundry), K-9 food, K-9 veterinary care
11 (medications), K-9 kenneling, vehicles, vehicle care and maintenance, handler training/travel,
12 explosives training/travel, and in costs associated with the deployment of Airport K-9 team(s)
13 in support of the Secure Automated Inspection Lane (SAIL II) Project; and

14 WHEREAS, The Airport will be reimbursed by the TSA \$168,240 for Fiscal Year
15 2006/07 for the Airport K-9 Explosives Detection Team Program expenses incurred at
16 AIRPORT; and

17 WHEREAS, The Airport will be reimbursed by the TSA \$1,125 for Fiscal Year 2006/07
18 in costs associated with the deployment of the Airport K-9 team(s) in support of the SAIL II
19 Project; and

20 WHEREAS, The Airport will be reimbursed by the TSA \$355,174 for the Airport K-9
21 Explosives Detection Team Program expenses incurred at the Airport during the period from
22 January 24, 2007 to September 30, 2007; and

23 WHEREAS, The Airport will be reimbursed by the TSA \$324,587 for Fiscal Year
24 2007/08 for the Airport K-9 Explosives Detection Team Program expenses incurred at Airport;


BOARD OF SUPERVISORS

5 0050, 07-0160, and 07-0222 dated October 3, 2006, February 20, 2007, June 19, 2007, and
6 September 18, 2007, respectively; now, therefore, be it

7 RESOLVED, That this Board of Supervisors hereby authorizes the Airport to accept
8 and expend the TSA funding for the Airport K-9 Explosives Detection Team Program; and be

10 FURTHER RESOLVED, That the Board of Supervisors hereby waives the inclusion of
11 indirect costs in the grant budget.


