

1 [Authorizing the Committee on Information Technology to amend its contract with Central
2 Computer Systems to increase its contract amount to ~~\$36-29~~ million.

3 **Resolution authorizing the Office of Contract Administration to enter into the Seventh**
4 **Amendment to the Agreement between the City and Central Computer Systems (part of the**
5 **Computer Store procurement vehicle), in which the amendment shall increase the contract**
6 **amount from \$25 million to \$3629 million.**

7 WHEREAS, the Committee on Information Technology and the Office of Contract
8 Administration, by competitive bidding, developed the Computer Store procurement method for
9 the purchase of products and services related to Information Technology; and

10 WHEREAS, the original contract with Central Computer Systems was dated
11 January 1, 2004; had a term of three years, through December 31, 2006, with possible extensions
12 through December 31, 2008, and has been amended as follows, with two amendments increasing
13 the contract amount as indicated:

- 14 First amendment, July 1, 2004,
- 15 Second amendment, February 11, 2005,
- 16 Third amendment, November 29, 2006, raised to \$19 million
- 17 Fourth amendment, December 29, 2006;
- 18 Fifth amendment, July 12, 2007, raised to \$25 million
- 19 Sixth amendment, December 28, 2007.

20 WHEREAS, the Office of Contract Administration estimates that the money projected to be
21 spent with Central Computer Systems could reach the contract amount in the reasonably near
22 future; and

1 WHEREAS, Charter section 9.118, "Contract and Lease Limitations," subsection (b),
2 requires Board of Supervisors approval of an amendment of greater than \$500,000 to a contract of
3 greater than \$10 million; now, therefore, be it

4 RESOLVED, that the Board of Supervisors authorizes the Office of Contract
5 Administration enter into the Seventh amendment to the contract with Central Computer Systems;
6 and be it

7 FURTHER RESOLVED, that said Amendment shall increase the contract amount for the
8 contract with Central Computer Systems from \$25 million to ~~\$36~~29million.


