3 **Resolution determining that the issuance of a Type 42 on-sale beer and wine public**  
4 **premises license to Joseph Latimore for Gallery Sensei, located at 251 Rhode Island**  
5 **Street (District 10), will serve the public convenience and necessity of the people of the**  
6 **City and County of San Francisco, in accordance with Section 23958.4 of the California**  
7 **Business and Professions Code, with conditions.**

10 WHEREAS, Joseph Latimore is seeking the issuance of a Type 42 on-sale beer  
11 and wine public premises license for Gallery Sensei, located at 251 Rhode Island Street  
12 (District 10); and,

13 WHEREAS, The Planning Department has verified that the area is properly  
14 zoned; and,

15 WHEREAS, The Police Department recommends that the liquor license  
16 application be approved with conditions; now, therefore, be it

17 **RESOLVED**, That in accordance with Section 23958.4 of the California Business  
18 and Professions Code, the Board of Supervisors of the City and County of San  
19 Francisco hereby determines for the foregoing reasons that the issuance of a Type 42  
20 on-sale beer and wine public premises license to Joseph Latimore for Gallery Sensei,  
21 located at 251 Rhode Island Street, will serve the public convenience and necessity of  
22 the people of the City and County of San Francisco.

23 Conditions: (1) Sales, service and consumption of alcoholic beverages shall be  
24 permitted between the hours of 9:00 a.m. to 1:30 a.m. each day of the week. (2) No  
25 noise shall be audible beyond the area under the control of the licensee(s). (3) The

1 petitioner shall not permit their patrons or the general public to loiter or congregate on  
2 the area adjacent to the licensed premises. (4) Loitering is prohibited on any sidewalks  
3 or property adjacent to the licensed premises under the control of the licensee. (5) The  
4 sale of alcoholic beverages for consumption off the premises is strictly prohibited. (6)  
5 No person under the age of twenty-one (21) years of age shall sell, furnish or deliver  
6 alcoholic beverages. (7) Graffiti shall be removed from the premises and all parking lots  
7 under the control of the licensee within 72 hours of application. If the graffiti occurs on a  
8 Friday or weekend day, or on a holiday, the licensee shall remove the graffiti within 72  
9 hours following the beginning of the next weekday. (8) The interior lighting maintained  
10 therein shall be sufficient to make easily discernible the appearance and conduct of all  
11 persons and patrons in the portion of the premises where alcoholic beverages are sold,  
12 served, delivered and consumed.


