[Urging the Board of Directors of the Bay Area Rapid Transit District (BART) to Establish an Independent Civilian Oversight Body to Investigate Claims of BART Police Misconduct]

Resolution urging the BART Board of Directors to immediately establish an independent Civilian Oversight body to investigate claims of misconduct by the BART Police, and urging our State Representatives to pass legislation requiring that BART have independent third-party civilian oversight of its Police force.

WHEREAS, It is an accepted best practice that police forces that operate in urban areas have independent third-party civilian oversight; and

WHEREAS, In the last few years, the need for independent and impartial third-party oversight has been illustrated by a number of incidents involving the BART police force, including the prior death of Gerald Hall and the most recent tragic death of Oscar Grant; and,

WHEREAS, As early as 10 years ago, then Supervisor Tom Ammiano made official inquiries about the BART Police and asked the BART Board of Directors to consider creating a civilian oversight body to investigate claims of misconduct by its police force; and

WHEREAS, Requests for independent civilian oversight have fallen on deaf ears as it has been more than a decade and the BART Board of Directors has not taken any steps to establish a civilian oversight agency; and

WHEREAS, The egregious nature of the circumstances surrounding the death of Oscar Grant and the appallingly slow pace of the incidents' investigation has led to a complete breakdown in trust and confidence between BART's Peace Officers and BART's ridership as well as widespread rioting within a community which depends heavily on BART service; and

WHEREAS, It is in the interest of the rank and file officers of BART's police force to have civilian oversight as an enhanced and impartial review of police conduct could reveal that BART's officers are operating within the confines of the law the vast majority of the time; and

WHEREAS, No modicum of trust between BART and the communities it serves can be restored until citizens of the Bay Area know that they have *meaningful* official recourse if they feel they have suffered abuse at the hands of BART's police force; and

WHEREAS, In light of the tragic death of Oscar Grant, Assemblyman Tom Ammiano and State Senator Leland Yee will be introducing legislation establishing independent thirdparty civilian oversight of the BART Police; now, therefore, be it

RESOLVED, That the San Francisco Board of Supervisors urges the BART Board of Directors to immediately establish an independent Civilian Oversight body to investigate claims of misconduct by the BART Police; now, therefore, be it

FURTHER RESOLVED, That the Board of Supervisors urges the California Assembly and Senate to pass Assemblyman Ammiano and Senator Yee's legislation requiring that BART have independent third-party civilian oversight of its police force.
