12 WHEREAS, The Golden Gate National Recreation Area which manages Ocean Beach  
13 was recently awarded \$16.1 million dollars in American Recovery and Reinvestment Act  
14 funds; and,

15 WHEREAS, The Golden Gate National Recreation Area has published a list of projects  
16 that will benefit from this funding; and;

17 WHEREAS, Improvements to Ocean Beach are not included on this list; and,

18 WHEREAS, New funding streams through the American Recovery and Reinvestment  
19 Act are coming online every week that could benefit improvements Ocean Beach; now,  
20 therefore, be it

21 RESOLVED, That the San Francisco Board of Supervisors urges the Golden Gate  
22 National Recreation Area to consider the needs of Ocean Beach when allocating the \$16.1  
23 million of American Recovery and Reinvestment Act funds; and, be it further
