3 **Resolution authorizing the San Francisco Department of Public Health (DPH), to accept**  
4 **and expend retroactively a grant in the amount of \$15,369 from the University of**  
5 **California, San Francisco (UCSF), the primary contractor, with funds from the Futures**  
6 **Group International, to support a project entitled “Project SEARCH Nigeria HIV**  
7 **Prevention Project;” for the period of April 1, 2009 through September 30, 2009.**

9 WHEREAS, UCSF is the recipient of a grant award from the Futures Group  
10 International, LLC, to fund HIV/AIDS prevention in Nigeria; and,

11 WHEREAS, It is considered in the best interest of the Futures Group, UCSF, and DPH  
12 to participate in this project; and,

13 WHEREAS, UCSF has agreed to reimburse DPH in the amount of \$15,369 to assist  
14 with this project for the period of April 1, 2009 through September 30, 2009; and,

15 WHEREAS, As a condition of receiving the funds UCSF requires DPH to enter into an  
16 agreement (the “Agreement”), a copy of which is on file with the Clerk of the Board of  
17 Supervisors in File No. 090807, which is hereby declared to be a part of this  
18 resolution as if set forth fully within; and,

19 WHEREAS, The grant does not require an ASO amendment and partially reimburses  
20 DPH for one existing position, a Health Program Coordinator III (Job Class 2593) at .20 FTE  
21 for the period of April 1, 2009 through September 30, 2009; and,

22 WHEREAS, A request for retroactive approval is being sought because DPH did not  
23 receive the required documents from UCSF until May 11, 2009; and,

24 WHEREAS, The budget includes a provision for indirect costs of \$1,647; now  
25 therefore, be it

8 agreement on behalf of the City; and, be it


9 FURTHER RESOLVED, That the Controller is directed to designate all positions




