Resolution authorizing the Chief of Police for the City and County of San Francisco to accept and expend a gift in the amount of \$40,000.00 from the *Supporters of the San Francisco Police Department's Wilderness Adventure Youth Program*, a non-profit organization [501 (c) (3)], for the purchase of two new passenger vans to use on Youth Wilderness Trips.

WHEREAS, The Chief of Police of the City and County of San Francisco desires to accept gift funds for the purchase of two new passenger vans; and

WHEREAS, The purchase of these two new vehicles will provide the ability to continue to safely and effectively transport students involved in the Police Department's Wilderness Program; and,

WHEREAS, The Chief of Police for the City and County of San Francisco is authorized on behalf of the City and County of San Francisco to accept these funds and purchase these two new passenger vans through the City and County of San Francisco's Fleet program; and

WHEREAS, This program requires no matching funds; and

WHEREAS, This program requires that the costs of ownership and maintenance over the life of the vehicles be incurred by the Police Department; and


WHEREAS, The execution of the gift does not require an ASO amendment; now, therefore, be it


