12 morning and a legion of fans; and

13 WHEREAS, More than any other Bay Area television or radio station, Energy 92.7
14 brought LGBT and straight listeners together using humor to break down barriers and to
15 create understanding and good will , and

16 WHEREAS, Energy 92.7 has been a strong partner to the City and County of San
17 Francisco through their unwavering support of community based organizations raising both
18 funds and awareness for non-profits that focus on HIV/AIDS, food banks, and breast cancer
19 among countless others, and

20 WHEREAS, Energy 92.7 has always prided itself on being a community driven station
21 responding to the needs of the Bay Area Community, now, therefore, be it
