

1 [Acceptance of Gift for Building Bocce Courts in Justin Herman Plaza]

3 **Resolution authorizing the Recreation and Park Department to accept a gift of labor**
4 **and construction materials with a value of \$61,000 from the Laborers Local 261**
5 **Community and Training Foundation to build two bocce courts on the lawn in Justin**
6 **Herman Plaza.**

8 WHEREAS, The lawn to the south of the Market Street streetbed in Justin Herman
9 Plaza is an underutilized area of an otherwise active plaza; and

10 WHEREAS, The Mayor's Office, in conjunction with the Recreation and Park
11 Department, desires to activate the plaza to create a vibrant, beautiful place for San
12 Franciscans to relax and recreate; and

13 WHEREAS, The Laborers Local 261 Community and Training Foundation (Donor) has
14 offered the City a gift of labor and construction materials to create bocce courts on the lawn;
15 and

16 WHEREAS, A conceptual site plan for the proposed project is on file with the Clerk of
17 the Board of Supervisors, which is hereby declared to be a part of this resolution as if set forth
18 fully herein; and

19 WHEREAS, This construction work requires no additional funds or work from the City;
20 and

21 WHEREAS, In the future, the City may decide to use this space in a different manner
22 that will require the removal of the bocce ball courts and Donor agrees to remove the courts
23 and restore the lawn to its original condition at its own expense; now, therefore, be it

24 RESOLVED, That the Recreation and Park Department is authorized to accept this gift
25 on behalf of the City on the condition that Donor will remove the courts and restore the lawn to

1 its original condition at its own expense if, in the future, the City decides to use the space in a
2 different manner; and, be it

3 FURTHER RESOLVED, That the Recreation and Park Department shall not allow for
4 the commencement of construction until such time as the Recreation and Park Commission
5 has granted approval of the site plan.


