WHEREAS, the Office of Contract Administration, by competitive bidding, developed the Technology Store procurement method for the purchase of products and services related to Information Technology; and

WHEREAS, Xtech is one of the three products vendors who are part of the Technology Store; and,

WHEREAS, the original contract with Xtech is dated January 1, 2009; has a term of three years, through December 31, 2011, with possible extensions through December 31, 2013, and has a contract amount of \$24 million; and

WHEREAS, the Board of Supervisors approved the original contract on December 9, 2008 by Resolution #508-08.

WHEREAS, the Office of Contract Administration estimates that the money projected to be spent with Xtech could reach the contract's contract amount in the reasonably near future; and

WHEREAS, Charter section 9.118, "Contract and Lease Limitations," subsection (b), requires Board of Supervisors approval of any contract estimated to exceed \$10 million in expenditures or amendments exceeding \$500,000 to such contracts; now, therefore, be it

RESOLVED, that the Board of Supervisors authorizes the Office of Contract Administration to enter into the First amendment to the contract with Xtech to update the standard contractual clauses; and be it
