10 WHEREAS, Christy Bergman is seeking the issuance of a Type 42 on-sale beer
11 and wine license for The Secret Wine Shop, located at 1097 Howard Street, #209; and,

12 WHEREAS, The City Planning Department has verified that the area is properly
13 zoned; and,

14 WHEREAS, The Police Department recommends that the liquor license
15 application be approved with conditions; now, therefore, be it

17 RESOLVED, That in accordance with Section 23958.4 of the California Business
18 and Professions Code, the Board of Supervisors of the City and County of San
19 Francisco hereby determines for the foregoing reasons that the issuance of a Type 42
20 on-sale beer and wine license to Christy Bergman for The Secret Wine Shop, located at
21 1097 Howard Street, #209, will serve the public convenience or necessity of the people
22 of the City and County of San Francisco.

24 Conditions: (1) Sales, service, and consumption of alcoholic beverages shall be
25 permitted only between the hours of 11:00 a.m. and 10:00 p.m. each day of the week.

1 (2) No person under the age of 21 shall sell or deliver alcoholic beverages. (3) No
2 noise shall be audible beyond the area under control of the licensee. (4) The interior
3 lighting maintained therein shall be sufficient to make easily discernible the appearance
4 and conduct of all persons and patrons in that portion of the premises where alcoholic
5 beverages are sold, served, delivered or consumed. (5) Petitioner shall not make
6 structural changes in the premises interior without prior written approval from the
7 Department.
