9 Shop at Laguna Honda Hospital and Rehabilitation Center for many decades; and

10 WHEREAS, Laguna Honda Volunteers, Inc. no longer operates the Green  
11 Angels Gift Shop, which is now closed; and

12 WHEREAS, Laguna Honda Hospital and Rehabilitation Center will reopen a gift  
13 shop on December 7, 2010; and

14 WHEREAS, Laguna Honda Volunteers, Inc. is in possession of merchandise  
15 related to furniture, fixtures, and equipment that is useful to operating the hospital's gift  
16 shop; and,

17 WHEREAS, Laguna Honda Volunteers, Inc has offered to donate such  
18 merchandise to Department of Public Health, Laguna Honda Hospital and Rehabilitation  
19 Center; and

20 WHEREAS, The new gift shop at Laguna Honda Hospital and Rehabilitation  
21 Center will make good use of the items; and

22 WHEREAS, Laguna Honda Hospital and Rehabilitation Center wishes to obtain  
23 approval from the Health Commission and the Board of Supervisors to accept the  
24 donation of the merchandise, furniture, fixtures and equipment; now, therefore, be it

1 RESOLVED, That the Department of Public Health, Laguna Honda Hospital and  
2 Rehabilitation Center is hereby authorized to accept this gift in accordance with the  
3 requirements set forth pursuant to San Francisco Administrative Code Section 10.100-  
4 305; and, be it

5 FURTHER RESOLVED, That the Department of Public Health, Laguna Honda  
6 Hospital and Rehabilitation Center is hereby authorized to accept a gift of \$14,000  
7 comprised of \$2,000 in merchandise and \$12,000 for furniture, fixtures and equipment.


