WHEREAS, In order to ensure the highest standards of medico-legal services be provided to the citizens of San Francisco, the Office of the Chief Medical Examiner of the City and County of San Francisco (OCME) is required to meet and maintain accreditation by the National Association of Medical Examiner's and the American Board of Forensic Toxicology; and,

WHEREAS, In order to meet these accreditation standards, the OCME requires new equipment, computer hardware and software and temporary staffing to perform validation studies and train/certify current employees in the Forensic Laboratory Division of the OCME; and,

WHEREAS, The OCME participated in a competitive process for and was selected to receive a grant from the Paul Coverdell Forensic Science Program to acquire and install Local Access Network (LAN) Interfaces and upgrade kits, a redundant nitrogen generator, a digital x-ray server, upgraded computer hardware and software, as well as staffing for validation studies and training/certification for personnel; and,

WHEREAS, The resolution does not require an ASO Amendment; and,

WHEREAS, The OCME proposes to maximize use of available grant funds on program expenditures by not including indirect costs in the grant budget; now, therefore, be it

RESOLVED, That the Board of Supervisors hereby waives inclusion of indirect costs in the grant budget; and, be it
