3 **Resolution approving a Memorandum of Understanding between the City and County**
4 **of San Francisco and San Mateo County regarding the application of the San Francisco**
5 **Local Hiring Policy for Construction to construction projects located within San Mateo**
6 **County.**

8 WHEREAS, The San Francisco Local Hiring Policy for Construction, Administrative
9 Code subsection 6.22(G) (the "Policy"), establishes mandatory local hiring requirements for
10 certain City public work or improvement projects, including but not limited to City projects
11 constructed in whole or in part in San Mateo County; and

12 WHEREAS, The Policy authorizes the Office of Economic and Workforce Development
13 ("OEWD") and City awarding departments to negotiate reciprocity agreements with other local
14 jurisdictions that maintain local hiring programs, provided that such agreements promote the
15 goals of the Policy; and

16 WHEREAS, The Policy provides that any reciprocity agreement negotiated by OEWD
17 or an awarding department under the Policy is subject to approval of the Board of Supervisors
18 by resolution; and

19 WHEREAS, San Mateo County funds and provides job training programs and
20 employment centers through its Human Services Agency and its participation, grant funding
21 and contracting with such entities as PeninsulaWorks and JobTrain; and

22 WHEREAS, OEWD has negotiated a Memorandum of Understanding ("MOU") with the
23 County of San Mateo regarding the application of the Policy for construction projects located
24 within San Mateo County, a copy of which is on file with the Clerk of the Board of Supervisors

1 in File No. 110490, which is hereby declared to be part of this resolution as if set forth fully
2 herein; now, therefore, be it

3 RESOLVED, That the Board of Supervisors hereby approves the MOU with the County
4 of San Mateo in substantially the form of the MOU on file with the Clerk of the Board of
5 Supervisors.
