[Urging the MTA to Require Quarterly Reports on the Implementation of Work Rule Changes]

Resolution urging the San Francisco Municipal Transportation Agency Board of Directors to require quarterly reports on the implementation of work rule changes.

WHEREAS, In November, 2010 San Francisco voters overwhelmingly supported Proposition G, which required collective bargaining, including for wages, between Transit Workers United Local- 250-A and the SFMTA; and

WHEREAS, The SFMTA and Local 250-A recently completed several months of bargaining; and

WHEREAS, The SFMTA Board of Directors approved the three-year agreement negotiated with Local 250-A between July, 2011 through June, 2014; and

WHEREAS, The SFMTA Board of Directors has stated publicly, and on June 14, 2011 produced financial statements pursuant to a sunshine request, that the value of the new agreement is \$41,000,000 and includes work rule changes that will result in significant Muni service improvement; and

WHEREAS, MUNI service has an everyday impact on the public and the quality of life in the City, and the success of implementing the new agreement is critical to improving MUNI service; and

WHEREAS, Tracking the implementation of work rule changes is an important way to ensure that those changes occur, now, therefore, be it

RESOLVED, That the Board of Supervisors urges the SFMTA Board of Directors to require a quarterly report and public hearing on the progress and details of implementing the work rule changes and included in the three year agreement between TWU Local 250- A and
