3 **Resolution honoring Chef Mourad Lahlou and proclaiming November 19, 2011, to be**  
4 **“Aziza Day”.**

6 WHEREAS, Chef Mourad Lahlou opened Aziza in San Francisco’s Richmond District in  
7 2001 and has recently celebrated its 10<sup>th</sup> anniversary in the neighborhood; and

8 WHEREAS, Aziza contributes to the culinary diversity of our city with a fine dining  
9 approach to traditional Moroccan cuisine; and,

10 WHEREAS, Chef Lahlou’s modern and sophisticated interpretations masterfully  
11 combine authentic Moroccan flavors with fresh and local ingredients; and

12 WHEREAS, Aziza supports local sustainable agriculture by purchasing their materials  
13 directly from local farms, ranches, and orchards who are committed to sound and wholesome  
14 habits; and

15 WHEREAS, In 2008, Chef Lahlou was named a “Rising Star Chef” by StarChefs; and

16 WHEREAS, In 2009, Chef Lahlou won Iron Chef America by the biggest margin in the  
17 show’s history; and

18 WHEREAS, In 2010, Aziza became the first Moroccan restaurant to receive a Michelin  
19 Star; and

20 WHEREAS, Aziza has since received a Michelin Star for three years in a row; and

21 WHEREAS, Recognizing its record consistency and sustained excellence, Zagat has  
22 named Aziza one of its top ten Bay Area restaurants of the decade; and

23 WHEREAS, Chef Lahlou, a true Moroccan-American pioneer, has released a new  
24 cookbook, *Mourad: New Moroccan*, to document and share his acclaimed recipes with an  
25 international audience; and

1           WHEREAS, In honor of the book's release, Chef Lahlou will be holding a book signing  
2 event at Green Apple Books on November 19, 2011; now, therefore, be it

3           RESOLVED, That the San Francisco Board of Supervisors hereby proclaims  
4 November 19, 2011 as "Aziza Day," as a means of celebrating Aziza and Chef Lahlou's great  
5 achievements and contribution to our city.




