7 and civil rights her passion and her vocation, starting with her residency in China, and
8 continuing with her work at the Homeless Advocacy Project; and

9 WHEREAS, Susan Mizner has been a leader in the City's efforts to fulfill the mandate
10 of the Americans with Disabilities Act of 1990 and ensure that the City's programs, policies,
11 and procedures are accessible to and usable by people with disabilities; and,

12 WHEREAS, Susan Mizner joined the City Family at the Mayor's Office on Disability in
13 1999 to advocate from the inside as a champion for disability rights, and in that position built
14 strong and productive relationships between the City and the disability community,
15 relationships that put a human face on the issues and help inform the City's policy makers as
16 they make critical decisions that affect and improve the lives of all citizens; and,

17 WHEREAS, Susan Mizner was responsible for the City's Americans With Disabilities
18 Act (ADA) Self-Evaluation Plan crafted by each individual department, which led to the
19 development of the City's comprehensive ADA Transition Plan; and,

20 WHEREAS, Susan Mizner has appeared before the Board of Supervisors on
21 numerous occasions, at each appearance advocating powerfully with grace, articulation,
22 humanity and humor; and therefore be it

23 RESOLVED, That the Board Of Supervisors hereby declare April 10, 2012, Susan
24 Mizner Day in honor of her retirement from the City and County of San Francisco.




