3 **Resolution approving an amendment to the contract with Addiction, Research, and**  
4 **Treatment, Inc., dba BAART, for methadone maintenance services to \$26,043,065.**

6 WHEREAS, The Department of Public Health selected Addiction, Research and  
7 Treatment, Incorporated dba BAART through a Request for Proposals (RFP 06-2008) issued  
8 on March 13, 2008, which provided for an initial contract term of one year with options to  
9 renew annually to a maximum term of ten years; and

10 WHEREAS, The contract enables services to approximately 866 clients annually of the  
11 Community Behavioral Health system at two community-based facilities on Market Street and  
12 Turk Street for methadone maintenance treatment for male, female, and transgender adults,  
13 and persons under the age of eighteen years on a case by case basis, and a methadone  
14 maintenance treatment service at Turk Street specifically for pregnant and post-partum  
15 women with parenting, nutrition, and education classes, medical and pediatric care, and group  
16 and individual counseling and case management, and

17 WHEREAS, The original contract, in the amount of \$8,202,621, was for a one and one-  
18 half year term of July 1, 2010 through December 31, 2011, which is hereby declared to be a  
19 part of this resolution as if set forth fully herein; Amendment One, in the amount of  
20 \$9,990,000, extends the contract to a five year term, from July 1, 2010 through June 30, 2015  
21 and

22 WHEREAS, The Department of Public Health wishes to increase the contract amount  
23 by \$16,053,065; now, therefore, be it

1 RESOLVED, That the Board of Supervisors authorizes the Director of Public Health  
2 and the Office of Contract Administration, on behalf of the City and County of San Francisco,  
3 to amend the contract with Addiction, Research and Treatment, Incorporated dba BAART for  
4 methadone maintenance services to increase the contract from \$9,990,000 for the period of  
5 July 1, 2010, through June 30, 2015, to \$26,043,065 for the period of July 1, 2010, through  
6 June 30, 2015.
