Rennie for Club OMG!, LLC, dba Club OMG!, will serve the public convenience or necessity of the people of the City and County of San Francisco, in accordance with Section 23958.4 of the California Business and Professions Code, with conditions.

WHEREAS, Mark E. Renne is seeking a transfer of a Type 48 on-sale general public premises liquor license from 181 Eddy Street to 43-6th Street for Club OMG!, LLC, dba Club OMG!; and,

WHEREAS, The Planning Department has verified that the area is properly zoned and recommends approval; now, therefore, be it

RESOLVED, That in accordance with Section 23958.4 of the California Business and Professions Code, the Board of Supervisors of the City and County of San Francisco hereby determines for the foregoing reasons that the transfer of a Type 48 on-sale general public premises liquor license from 181 Eddy Street to 43-6th Street to Mark E. Renne for Club OMG!, LLC, dba Club OMG!, will serve the public convenience or necessity of the people of the City and County of San Francisco.

Conditions: (1) The sales, service and consumption of alcoholic beverages shall be permitted only between the hours of 12:00 p.m. (noon) and 2:00 a.m. each day of the week. (2) The sale of alcoholic beverages for consumption off the premises is strictly prohibited. (3) No noise shall be audible beyond the area under the control of the licensee(s) as defined on ABC-257. (4) Loitering (loitering is defined as "to stand idly

about; linger aimlessly without lawful business") is prohibited on any sidewalks or property adjacent to the licensed premises under control of the licensee. (5) Between the hours of 9:00 p.m. and to until one half (1/2) hour past closing, the petitioner(s) shall provide security personnel who shall maintain order therein and prevent any activity which would interfere with the quiet enjoyment of their property by nearby residents. Security personnel shall be readily identifiable as security. (6) The petitioner shall utilize electronic surveillance and recording equipment that is able to view all exits and entrance points of the exterior of the premises. The electronic surveillance/recording shall be operational at all times that the premises are open to the public. Said electronic recording shall be maintained and kept for a minimum of seven (7) days, and shall be made available to Law Enforcement on demand.
