3 **Resolution authorizing the Department of Juvenile Probation to retroactively accept**
4 **and expend a grant in the amount of \$100,000 from the Federal Formula Grants**
5 **Program for the Disproportionate Minority Contact Support Project, administered by**
6 **the Corrections Standards Authority for calendar year 2012, to be used to support the**
7 **Juvenile Probation Department's efforts to reduce Disproportionate Minority Contact in**
8 **the Juvenile Justice system.**

10 WHEREAS, The Juvenile Probation Department desires to continue to participate in
11 the Disproportionate Minority Contact (DMC) Support Grant Project; and

12 WHEREAS, The purpose of the DMC Support Grant Project is to support local
13 probation departments in reducing the racial and ethnic disparity in juvenile justice contacts by
14 strengthening and supporting those departments' DMC reduction activities; and

15 WHEREAS, The grant does not require an Annual Salary Ordinance amendment; and

16 WHEREAS, The Juvenile Probation Department has been selected to receive the 3rd
17 year of the DMC Grant from the Corrections Standards Authority; now, and

18 WHEREAS, The Department proposes to maximize use of available grant funds on
19 program expenditures by not including indirect costs in the grant budget; now, therefore, be it


20 RESOLVED, That the Juvenile Probation Department of the City and County of San
21 Francisco is authorized to enter into the attached grant award agreement on behalf of the
22 City; and be it


23 FURTHER RESOLVED, That the Board of Supervisors hereby waives inclusion of

3 of grant funds for the benefit of the San Francisco Juvenile Probation Department; and be it

4 FURTHER RESOLVED, That the City and County of San Francisco will adhere to the
5 requirements of the Corrections Standards Authority and all conditions specified in the grant
6 agreement.


