3 **Resolution approving the Second Amendment to Contract No. CS - 159 between the**
4 **Municipal Transportation Agency and the Transbay Joint Powers Authority for**
5 **Transbay Transit Center program services pursuant to Charter, Section 9.118, to**
6 **increase the not to exceed amount from \$3,280,677 to \$5,393,677 for the period of July**
7 **21, 2009, through December 31, 2017.**

9 WHEREAS, The San Francisco Municipal Transportation Agency (SFMTA) is a
10 governmental entity which is comprised of the San Francisco Municipal Railway (Muni) and
11 former Department of Parking and Traffic (DPT); and

12 WHEREAS, On August 21, 2007, the SFMTA and the Transbay Joint Powers Authority
13 (TJPA) executed an agreement to provide SFMTA staff to support construction of the new
14 Transbay Transit Center; and

15 WHEREAS, On July 21, 2009, the SFMTA and the TJPA entered into Contract No. CS-
16 159, SFMTA Transbay Transit Center Program Services, under which the TJPA agreed to
17 reimburse the SFMTA for engineering services related to re-routing of Muni's trolley coach
18 service to accommodate the new TJPA temporary bus terminal; and

19 WHEREAS, SFMTA and TJPA entered into a First Amendment to this Agreement on
20 August 9, 2010, adding SFMTA Parking Control Officer services for the operation of the
21 Temporary Transbay Terminal during key commute hours to the scope of work, increasing the
22 contract amount, and extending the term of the Agreement; and

23 WHEREAS, The SFMTA and the TJPA have negotiated a Second Amendment to
24 Contract No. CS-159, SFMTA Transbay Transit Center Program Services, for additional

1 SFMTA staff support services required for the ongoing development of the Transbay
2 Terminal; and

3 WHEREAS, Under the Second Amendment, SFMTA will provide additional services
4 including additional or amended project management, construction management, inspection,
5 engineering, planning, and coordination support for the Transbay Terminal; and

6 WHEREAS, The SFMTA and TJPA have agreed to increase the contract amount from
7 \$3,280,677 to an amount not exceeding \$5,393,677 to reimburse the SFMTA for these
8 additional or amended services, and

9 WHEREAS, The Second Amendment to Contract No. CS-159 also extends the
10 contract term from December 15, 2015 to December 31, 2017 to ensure completion of the
11 new Transbay Transit Center; and

12 WHEREAS, On February 5, 2013, the SFMTA Board of Directors adopted Resolution
13 13-018, to authorize the SFMTA Director of Transportation to execute the Second
14 Amendment to Contract No. CS-159; now, therefore, be it

15 RESOLVED, That the Director of Transportation of the SFMTA is hereby authorized,
16 on behalf of the City, to execute the Second Amendment to Contract No. CS-159, SFMTA
17 Transbay Transit Center Program Services, pursuant to Charter Section 9.118.




