

1 [Accept and Expend Grant - Pedestrian and Bicycle Projects - \$865,864]

3 **Resolution authorizing the acceptance and expenditure of State Transportation**
4 **Development Act Article 3 grant funds for various pedestrian and bicycle projects in**
5 **San Francisco in FY2013-2014, totaling \$865,864 including \$432,932 for the Department**
6 **of Public Works and \$432,932 for the Municipal Transportation Agency for the period of**
7 **September 1, 2013, through August 31, 2016.**

9 WHEREAS, Article 3 of the Transportation Development Act (TDA), California Public
10 Utilities Code Section 99230 *et seq.*, authorizes the submission of claims to a regional
11 transportation planning agency for the funding of projects exclusively for the benefit and/or
12 use of pedestrians and bicyclists; and

13 WHEREAS, The Metropolitan Transportation Commission (MTC), as the regional
14 transportation planning agency for the San Francisco Bay region, has adopted MTC
15 Resolution No. 875, Revised, entitled "Transportation Development Act, Article 3,
16 Pedestrian/Bicycle Projects," which delineates procedures and criteria for submission of
17 requests for the allocation of TDA Article 3 funds; and

18 WHEREAS, MTC Resolution No. 875, Revised, requires that requests for the allocation
19 of TDA Article 3 funding be submitted as part of a single, countywide coordinated request
20 from each county in the San Francisco Bay region; and

21 WHEREAS, The San Francisco Municipal Transportation Agency (SFMTA) and the
22 Department of Public Works (DPW) are eligible to request allocations of TDA Article 3 funds
23 pursuant to Sections 99233.3 and 99234 of the California Public Utilities Code; and

1 WHEREAS, SFMTA and DPW desire to submit a request to MTC for an allocation of
2 TDA Article 3 funds to support eligible projects that are for the exclusive benefit and/or use of
3 pedestrians and/or bicyclists; and

4 WHEREAS, The SFMTA has identified \$432,932 in projects for the engineering,
5 construction, maintenance and project management of bicycle facility projects in San
6 Francisco to be funded from Fiscal Year 2013-2014 TDA Article 3 funds; and

7 WHEREAS, There is no legal impediment or pending or threatened litigation that might
8 adversely affect the implementation of bicycle facility projects; and

9 WHEREAS, The City's Planning Department has determined that the SFMTA's actions
10 contemplated in this Resolution are in compliance with the requirements of the California
11 Environmental Quality Act (CEQA, Public Resources Code Sections 21000 *et seq.*), which
12 decision has been upheld by the Board of Supervisors; said determination is on file with the
13 Clerk of the Board of Supervisors in File No. 130679 and is incorporated herein by reference;
14 and

15 WHEREAS, The SFMTA Board of Directors adopted Resolution No. 13-065 at its June
16 4, 2013 meeting, authorizing the Director of Transportation of the SFMTA (or his designee) to
17 accept and expend \$432,932 of FY 2013-2014 TDA Article 3 funds for bicycle facility projects;
18 and

19 WHEREAS, DPW has identified \$216,466 in work for the preliminary engineering and
20 design of curb ramps to be constructed at various locations throughout San Francisco, as
21 required by the federal Americans with Disabilities Act, to be funded from FY 2013-2014 TDA
22 Article 3 funds; and

23 WHEREAS, DPW has identified \$216,466 in work to repair public sidewalks at various
24 locations throughout San Francisco to be funded from FY 2013-2014 TDA Article 3 funds; and

1 WHEREAS, There is no legal impediment or pending or threatened litigation that might
2 adversely affect DPW's projects described above, or that might impair the ability of DPW to
3 implement the projects; and

4 WHEREAS, Environmental and right-of-way issues have been reviewed, and will not
5 jeopardize DPW's ability to meet fund obligations deadlines; and

6 WHEREAS, The City's Planning Department has determined that DPW's actions
7 contemplated in this Resolution are in compliance with the requirements of the California
8 Environmental Quality Act (CEQA, Public Resources Code Sections 21000 *et seq.*); said
9 determination is on file with the Clerk of the Board of Supervisors in File No. 130679 and is
10 incorporated herein by reference; and

11 WHEREAS, The SFMTA's and DPW's staffing resources are adequate to complete the
12 projects; and

13 WHEREAS, Adequate local funding is available to complete the projects; and

14 WHEREAS, The projects are ready to commence implementation during the fiscal year
15 of the requested allocation; and

16 WHEREAS, The SFMTA and DPW agree to maintain or provide for the maintenance of
17 the projects for the benefit of and use by the public; and

18 WHEREAS, DPW's proposed grant budget includes indirect costs of \$179,000 and the
19 SFMTA's grant budget includes indirect costs of \$160,000; now, therefore, be it

20 RESOLVED, That this Board of Supervisors authorizes the San Francisco Municipal
21 Transportation Agency and the Department of Public Works to accept and expend up to
22 \$865,864 in state TDA Article 3 funds for FY 2013-2014 for the projects described above and
23 to execute all required documents for receipt of such funds pursuant to San Francisco
24 Administrative Code section 10.170-1.




