1 [Liquor License Transfer - 6333 Geary Boulevard]

3 **Resolution determining that the transfer of a Type 21 off-sale general license from**  
4 **701 Fillmore Street to 6333 Geary Boulevard (District 1), to Patrick Davis for**  
5 **Grocery Outlet, Inc., dba Grocery Outlet, will serve the public convenience or**  
6 **necessity of the City and County of San Francisco, in accordance with California**  
7 **Business and Professions Code, Section 23958.4.**

9 WHEREAS, Patrick Davis is seeking the transfer of a Type 21 off-sale general  
10 license from 701 Fillmore Street to 6333 Geary Boulevard (District 1) for Grocery Outlet,  
11 Inc., dba Grocery Outlet; and,

12 WHEREAS, The Planning Department has verified that the area is properly  
13 zoned and recommends approval; and,

14 WHEREAS, The Police Department has filed no protests with the Department of  
15 Alcoholic Beverage Control under the California Business and Professions Code,  
16 Section 24013, and recommends that the Department of Alcoholic Beverage Control  
17 issue the liquor license with conditions; and,

18 WHEREAS, The conditions recommended by the Police Department are the  
19 following: 1) Sales, service and consumption of alcoholic beverages shall be between  
20 7:00 a.m. and 12:00 midnight daily; 2) No more than 10% of the square footage of the  
21 premises shall be used for the display of alcoholic beverages; 3) The sale of distilled  
22 spirits in sizes smaller than 200 ml is strictly prohibited; 4) Noise shall not be audible  
23 beyond the area under the control of the licensee as depicted on ABC-257; and 5) The  
24 sale of beer or malt beverages in quantities of 20 oz., 22 oz., 24 oz., 40 oz., or similar

1 size containers is prohibited, except for microbrews, craft brews, organic and specialty  
2 malt products sold under such designations as stout, porter, IPA, and ESB. This  
3 condition is intended to eliminate high-alcohol, low-cost products that are frequently  
4 abused, but not prevent the sale of specialty and craft beer products; now, therefore, be  
5 it

6           RESOLVED, That in accordance with the California Business and Professions  
7 Code, Section 23958.4, the Board of Supervisors of the City and County of  
8 San Francisco hereby determines for the foregoing reasons that the transfer of a Type  
9 21 off-sale general license from 701 Fillmore Street to 6333 Geary Boulevard (District 1)  
10 for Grocery Outlet, Inc., dba Grocery Outlet, will serve the public convenience or  
11 necessity of the City and County of San Francisco.


