6 WHEREAS, A Consolidated Statewide Direct Primary Election was conducted in the  
7 City and County of San Francisco on Tuesday, June 3, 2014, which placed before the  
8 electorate candidates for election to City and County offices and City and County ballot  
9 measures; and

10 WHEREAS, John Arntz, the Director of Elections of the City and County of San  
11 Francisco, has certified the results of the Consolidated Statewide Direct Primary Election, a  
12 copy of which is on file with the Clerk of the Board of Supervisors in File No. 140711, which is  
13 hereby declared to be a part of this Resolution as if set forth fully herein; now, therefore, be it

14 RESOLVED, That the Board of Supervisors declares, under California Elections Code,  
15 Sections 9269 and 15400, the results of the Consolidated Statewide Direct Primary Election  
16 conducted in the City and County of San Francisco on Tuesday, June 3, 2014, as certified by  
17 the Director of Elections, as follows:


