10 newspaper of the City and County of San Francisco, pursuant to Administrative Code,
11 Sections 2.80-1 and 2.81; now, therefore, be it

12 RESOLVED, That *San Francisco Print Media Co.*, commonly known as *The Examiner*,
13 and *The San Francisco Chronicle*, newspapers of general circulation published in the City and
14 County of San Francisco for the dissemination of local or telegraphic news and intelligence of
15 a general character, having a bona fide circulation of at least 50,000 copies per calendar
16 week are hereby designated as official newspapers of the City and County of San Francisco
17 for the publication of all official advertising of the City and County for FY2015-2016; and, be it

18 FURTHER RESOLVED, That the Office of Contract Administration is hereby
19 authorized to enter into a contract with *San Francisco Print Media Co.*, commonly known as
20 *The Examiner*, for the period of July 1, 2015, through December 31, 2015, and The San
21 Francisco Chronicle for the period of January 1, 2016, through June 30, 2016, and said
22 contract(s) must be in accordance with all the contracting requirements of the City and County
23 of San Francisco.
