Hearing to consider that the premise-to-premise transfer of a Type-21 off-sale general beer, wine, and distilled spirits liquor license to Dalda's Inc., doing business as Dalda's Market, located at 168-186 Eddy Street (District 6), will serve the public convenience or necessity of the City and County of San Francisco. An ABC Type-21 for grocery use is permitted as accessory--liquor sales can only occupy less than 15% of the occupied floor area of the establishment (including areas for display and sales), per Planning Code, Section 102. Grocery use is principally permitted in the RC-4 Zoning District per Planning Code, Section 209.3.

Access/Inability getting to evacuation center: Mel's Drive-in <Geary/Beaumont> Traffic gridlocked. On cold days, blankets & hot drinks rather than iced water bottles better. Agency Roles: My contacts to get "Return-to-normalcy": • Missed garbage pickups • Missed street cleanings • School bus barred from entering street to pick up disabled child • Alerted City Hall additional re 2/18-2/26/19 permit for utility conduit laying • Still missing traffic signs thru 5/21/2019 → safety Agendize this every 3 months until all vetted. Richmond District & Jordan Park areas should not re-experience this."
