240103 [Liquor License Transfer - 555 Fulton Street, Suite C - Trader Joe's Company]

Hearing to consider that the person-to-person, premise-to-premise transfer of a Type-21 off-sale general beer, wine, and distilled spirits liquor license to the Trader Joe's Company, doing business as Trader Joe's Store 226, located at 555 Fulton Street, Suite C (District 5), will serve the public convenience or necessity of the City and County of San Francisco. (Public Safety and Neighborhood Services Committee)

The applicant submitted a request for a determination on the public convenience or necessity of the transfer of a Type-21 off-sale general beer, wine, and distilled spirits liquor license to the Trader Joe's Company, doing business as Trader Joe's Store 226, located at 555 Fulton Street.

02/02/24; RECEIVED AND ASSIGNED to Public Safety and Neighborhood Services Committee.

02/02/24; REFERRED TO DEPARTMENT. Referred to the Planning Department and Police Department for recommendation.

02/09/24; RESPONSE RECEIVED. Planning recommends approval for ABC Type-21 license in conjunction with conditionally permitted Grocery Store use (d.b.a Trader Joes) in the RTO and Hayes NCT Zoning District per Planning Code Section 209.4 and 761. Planning Commission Motion No. 20946 permits the Formula Retail Grocery Store use at the Subject Property. Grocery Stores may provide beer, wine, and distilled spirits for consumption off the premises with a ABC License Type-21 (Off-Sale General) under the condition that all areas devoted to the display and sale of alcoholic beverages do not exceed 15% of the Occupied Floor Area of the establishment. The Subject Property must adhere to the conditions outlined in Planning Commission Motion No. 20946 and the conditions of Planning Code Section 202.2(a)(1).

02/15/24; RESPONSE RECEIVED. The Police Department submitted a response recommending approval with the following condition:

1) Petitioner(s) shall actively monitor the area under their control in an effort to prevent the loitering of persons on any property adjacent to the licensed premises as depicted on ABC-253.

Heard in Committee. Speaker(s): Officer Joel Salmonson (Police Department); Dan Kramer (Dan Kramer Law Group); presented information and answered questions raised throughout the discussion.

A determination that the public convenience or necessity would be served was recommended by the committee.

Vice Chair Engardio moved that this Hearing be PREPARED IN COMMITTEE AS A RESOLUTION, making a determination that the transfer of a Type-21 off-sale general beer, wine, and distilled spirits liquor license to the applicant will serve the public convenience or necessity. The motion carried by the following vote:
