The Warriors defeated the Boston Celtics 103-90 in Game 6 on Thursday evening to win the best-of-seven series 4-2 and clinched their first championship since moving from Oakland, where the team played for 48 years, to San Francisco in 2019.

Festivities begin at 11:20 a.m. and conclude at about 2 p.m. The route, which will be 1.04 miles, starts on Market Street at Main Street and will end at Market and 6th streets.

The team says the parade will be "a free-flowing and engaging celebratory event for fans, with the opportunity to share in the up-close excitement of the 2022 NBA Championship with the Warriors, their players, coaches, legends and staff."
