SF Transgender Film Festival returns for its 26th year

Five programs shown online and at the Roxie Theater highlight subjects' humanity

eturning for its 26th year, the San Francisco Transgender Film Festival arrives at a time when understanding and empathy for trans people have perhaps increased — but so too has the persecution and discrimination against them, making the event all the more essential.

The festival — which launches in person on Nov. 8 at the Roxie Theater and online Nov. 11-19 — is dedicated to showcasing the humanity of the films' transgender and gender-nonconforming

Curated by Shawna Virago, whose day job is punk-rock singer-songwriter, the festival consists of 33 short films in five programs. The lineup is open to any and all trans and nonbinary experiences, from the tender to the perverse.

"Belonging: An Indian Trans Immigrant Story," directed by Amir Jaffer, tells the harrowing story of Anjali Rimi, a transgender woman who faced prejudice, scorn and even violence, both at home and in the U.S. But despite setback after setback, Rimi formed an organization

called Parivar ("family"), dedicated to "economic justice, trans unity & immigrant equity."

"Belonging" finds its most touching moments when it interviews Rimi's mother, who is still trying to understand her daughter's jour-

ney. The two women bring out a wrenching honesty in each other.

Aside from documentaries, the festival contains a multitude of genres, including animation, comedy, horror, coming-ofage, dance, experimental works, personal

essays, music videos, and erotica.

Rae Dawn's "City Folx: The Ads" is the first of a comedy web series about two drag brothers (Vera Hannush and

Bex Salas) barely able to scrape up rent in San Francisco's monumentally expensive housing market.

Constantly harassed by their landlady

and forever facing eviction, they decide to post an ad for a roommate, the text of which turns into a thing of comical poetry.

Roberto Fatal's "Do Digital Curanderas Use Eggs In Their Limpias?" is a serious short with a sci-fi slant. It occurs in a world where down-and-out citizens can abandon their earthly bodies and upload their essences to the utopia-like Digisphere.

With its strong performances, its clever use of story, and its general mood of bittersweet and heartbreak, this one is a mini-powerhouse.

Drew de Pinto's "Last Call" is a touching, poetic tribute to the Stud and other drag bars that were existentially threatened by the COVID-19 pandemic, with offscreen narration by Sister of Perpetual Indulgence Mary Timothy Simplicity.

Nicolas Collins's "Prittyboi" is a sweet, keenly-edited music video following two lovers (Christian Hotchkiss and Paloma Tenorio) — both clad in pastel tuxedo shirts — as they spend a romantic day walking around, goofing off, and just being near each other. The song by Pandaraps, catchy and confident, is about coming out as genderqueer.

Queer, trans, nonbinary and indigenous Mexican filmmaker Ramses Rodstein directs and stars in "The Hanky," an erotic short about a character who meets a handsome stranger in the park via a dropped handkerchief.
